

## **Official Rules**

Cinderella at the Lyric Opera Ticket Giveaway | Rules & Regulations

**1. NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** The Cinderella at the Lyric Opera Ticket Giveaway (the “Sweepstakes”) is open to legal residents of Illinois who are 18 years of age or older. Void where prohibited.

**2. Sweepstakes Period:** The Cinderella at the Lyric Opera Ticket Giveaway (the “Sweepstakes”) will run from 12/5/18 at 12:00PM CST until 12/31/18 at 12:00AM CST. Participants will have the opportunity to enter once during the Sweepstakes Period. Eligible winners may only win one time during the Sweepstakes Period. Winner will be notified using the email address provided to enter the Sweepstakes.

**3. How To Enter:** Click Giveaway tab on Roosevelt Collection Shops Facebook page or visit URL <http://www.facebook.com/RooseveltCollection>, ‘Like’ the page, scroll down to complete the sweepstakes registration form, click submit and you are entered to win Limit one (1) entry per person, per contest day. Sponsor’s designated official judging organization’s computer is the official time keeping device for this Sweepstakes. No other forms of entry are valid.
